Hiawatha Schools USD 415 2020 State-of-the-District Online Survey Final Report February 25, 2020

Introduction

Uncovering, understanding and managing stakeholder perception has been a focus of Hiawatha Schools USD 415, and these actions are evident by the district conducting its second State-of-the District (SOTD) survey.

In January, SOTD online surveys were made available to four key constituent groups in the district – parents, staff, community members and high school students. The only differences among the surveys were the demographic questions and some questions were not asked to students because they would not have the knowledge to answer.

The survey was intended to gauge the current views on a variety of aspects of the district's performance, determine what information sources stakeholders use for school district news and information, and seek stakeholders' thoughts on facility needs and usage.

Survey response totals by group included:

Parents - 194 High school students - 170 Community - 114 Staff - 95 Total responses - 573

The total number of survey respondents increased from the previous year's survey by 18 percent. The largest group increase was in community members who went from 42 respondents in 2018 to 114 respondents (171 percent increase) in 2020 – and among the community respondents, there was an increase of 35 percent of non-parent patrons.

Please note, not all individuals who participated answered all the questions - a situation that is typical with online surveys.

The results of the online surveys are shown below, along with comparison numbers from a few

questions that were also on the previous year's surveys. As this data is reviewed, please note the percentages may add to more or less than 100 percent, due to rounding.

1. What grade – A, B, C, D or F – would you give the Hiawatha Schools USD 415 on the following areas? Results on this question are reported, using a 5-point weighted scale. In this scale, 4.00 is considered the equivalent of a "B," and "n" is the number of participants in each group who responded.

Based on a 5-point weighted scale – where 5.00=A, 4.00=B, 3.00=C and 2.00=D – all the district factors in 2020 received a grade above a 3.00. An overall score of 5.00 is only possible if all respondents answered each statement with an A.

The top-performing factor (highlighted) for parents, staff and students was "Safety of students," while community members rated "Quality of instruction" as the top factor.

The items with the lowest scores included "The district's efforts to involve the community in decision-making" and "The district's responsiveness to citizen concerns." While these factors were rated low — which is typical — the staff, community and student rankings of these factors increased in agreement from 2018. However, parents ranked them lower. The district should continue implementing its communications efforts/community outreach — Red Hawk Talks, district newsletter, Virtual Citizens Advisory Committee, for example — and be mindful to have representation from parents.

2. How important do you think it is that the school district have facilities for vocational/technical programs? This question was asked in the spring 2019 Virtual Citizens Advisory Committee survey.

The top communications source for all the audiences was "School- or school-district-affiliated social media" with "Teachers and other staff members" ranked second. These were also the top two sources in the 2018 survey, except for community members ranking "Newspaper" as the second highest source.

Although social media is the news source your stakeholders turn to first, not every audience uses social media, and a large majority uses more than one communications channel. Therefore, you should employ the C.O.P.E. strategy – create once, publish everywhere.

Consider the ways to use an image and accompanying narrative across digital and printed content. C.O.P.E. is not just about using the same content on different social media platforms. It can be a powerful (and oftentimes freeing) strategy to quickly build effective district and school newsletters, websites, fliers, or other outputs around consistent and strategic content.

8. The district is starting a Virtual Citizens Advisory Committee. In this group, there are no meetings. Participants are simply asked to complete a 5-minute online survey – covering school district topics and ideas – about four or five times a year. Would you be willing to take part – at least try the first one or two surveys – to share your input with the district?

Possibly NEK-CAP Head Start and Early Head Start partnership could be very beneficial for the community.

STAFF

Hopefully you include preschool for all students!

I don't think we should keep the old building.

A new elementary is not necessary.

Early childhood development and Board office.

Utilize the space as a "club" Space for different school organizations such as KAYS, musical groups, study areas and other clubs.

Remodel it! Why would you move the district offices there? That would be another cost when they have a good building.

Keep the playground available and use the buildings for NECAP or early childhood.

I do not feel it is in the best interest of the district to build a new school at the expense of your employees. Making more room at the elementary does not ensure you will be able to fill all your positions without a competitive wage.

COMMUNITY

It doesn't matter, since the buildings aren't taken care of. With the current track record of building maintenance (entire district), whatever moves in won't be able to stay long.

Focus on making the high school better first. We have leaking ceilings and plumbing problems.

Classrooms for grades. Some grades in the old building and some grades in the new building.

Don't tie up more tax dollars in a building that is still usable.

I am very disappointed there are not spaces to make comments. I would think they would want to know why they were graded below a B or C.

Create a place for the children within the community (include ACES summer food program and a place for children to go in the summer for the parents who need it).s

Sell it to the city.

Don't need a new one.

Use the building for technical training classes; there are so many students where college just isn't the right fit and giving them a trade would greatly impact their lives.

Just add on and save money.

Tutor area for kids who are struggling.

Collaborating with your local Head Start program would be a wonderful idea. Head Start is an amazing program and would benefit families in the community if HES and Head Start were to combine forces and do what is best for these young students.

Sell it.

Add onto the current site, build a gymnasium and maybe move a few other classrooms over to new building. A sheltered walkway can connect the two.

A sports facility or a gym.

Use it for something useful, like a summer lunch program for the kids that is not a jail. Maybe try feeding the kids actual meals, instead of appetizers as a main course. What a waste.

Move pre-k and kindergarten to the annex or a new building and use the rest for 1-4. The annex and tech buildings are not being used wisely. Then you can spend the money on more important things such as the quality of the education.

Donate it for community center.

We don't need another school or tax.
